Introduction

The digital platforms belonging to Parques de Sintra – Monte da Lua, S.A. (henceforth Parques de Sintra) use cookies to improve performance and user experience. Parques de Sintra's digital platforms use their own and third party cookies. Some cookies are compulsory for browsing (basic and essential cookies), which are activated automatically when the user accesses and uses these digital platforms.

To ensure just the basic functionalities of Parques de Sintra's digital platforms, the data collected by the basic and essential cookies used on these platforms are compulsory in order to provide a quality service without restricting performance.

To guarantee security, avoid fraud and correct errors, your data may be used to monitor and prevent fraudulent activities and ensure that the systems and processes operate adequately and securely.

To access a better user experience, you can opt for cookies that allow the promotion of advanced functions on Parques de Sintra's digital platforms.

At any point, you can configure your internet browser to accept or reject new cookies, as well as to deactivate cookies previously stored on your device. Rejecting the use of cookies on Parques de Sintra's digital platforms can limit or prevent access to some areas and/or content, or limit the reception of personalised information.

1. Purpose

This document (henceforth 'Cookies Policy') contains information about cookies and similar technology installed on the user's device when they visit the domain www.parquesdesintra.pt, which comprehends the official website and the online ticket office subdomains, including the B2B platform and the Online Shop, and it should be read before browsing.

2. Cookies stored by Parques de Sintra – Monte da Lua, S.A

2.1 What are they?

Cookies – or similar technology that allows access to the user's device (which, for reasons of ease, are all referred to in this Cookies Policy as 'cookies') – are files that contain a small amount of information and which are sent to the user's browser from the site they are visiting, then stored on the internal memory of their device (e.g. computer or smartphone) or on their browser. Cookies allow the site to recognise the device and learn, for example, the preferences and browsing actions associated with this device, as well as facilitating the browsing experience and directing personalised marketing at users, as well as other purposes described in this Cookie Policy.

In some cases – cookies essential to the functioning of the site and service provision – they allow browsing and the transmission of information. When cookies are strictly necessary for the functioning of the site or for service provision – in the terms of Article 5 (2) of Law no. 41/2004, of 18 August (in its wording as per the most recent amendment given by Law no.46/2012, of 28 August) – they will be stored on the user's device at the time of visiting the

site. Otherwise, this only takes place once consent is given.

As a rule, Parques de Sintra only collects anonymous information that does not allow it to learn the identity of a specific user, associating the information to a given device, but without knowing the user's identity, with the exception of the cases indicated. Information relating to IPs can be used to prevent improper use of the services provided by Parques de Sintra, being used to safeguard the legitimate interest of Parques de Sintra in preventing this improper use (prevention of and fighting attempted fraud). More detailed information can be found in the Parques de Sintra Privacy Policy.

2.2 Purposes and Functions

The management of cookie definitions on Parques de Sintra's digital platforms aims to give users as much information as possible about the types of cookies used to make it possible to explore the digital platforms of Parques de Sintra and its partners, as well as the corresponding legal description.

Cookies have different purposes and functions, namely:

Purposes: these are the purposes of the data processing carried out by Parques de Sintra and its partners and which are dependent on the user's consent.

Purpose 1: To store and/or access information on a device;

Purpose 2: To select basic advertisements;

Purpose 3: To create a profile of personalised advertisements;

Purpose 4: To select personalised advertisements;

Purpose 5: To create a profile of personalised content;

Purpose 6: To select personalised content;

Purpose 7: To measure the performance of the advertisement;

Purpose 8: To measure the performance of the content;

Purpose 9: To apply market research results to generate perspectives on the public.

Purpose 10: To develop and improve products.

Functions: in respect of the functions of personal data processing related to the Purposes.

Function 1: To compare and combine sources of offline data;

Function 2: To link different devices;

Function 3: To receive and use the device's characteristics which are sent automatically for identification.

Special Purposes: these are the purposes of the data processing carried out by partner entities, which are not dependent on the user's consent.

Special Purpose 1: To guarantee security, avoid fraud and correct errors;

Special Purpose 2: To offer personalised advertisements or content.

2.3 How long do they last?

There are session cookies – which normally expire when the user disconnects the browser, whose purpose only lasts for one session (e.g. saving objects in a shopping trolley) – and persistent cookies, which remain beyond the end of the session, and which allow the site to recognise the device in future interactions. The website dedicated to ticket sales only uses session cookies.

2.4 Who do they belong to?

There are also original cookies (first-party cookies), installed on the user's device by Parques de Sintra, and third-party cookies, installed by a different domain than the one visited, due to the fact that Parques de Sintra has these cookies incorporated in its page. These cookies involve the transfer of the user's information to third-party entities, after the user gives their consent on the digital platform, for which reason their respective cookie and privacy policies should also be consulted.

2.5 What kind are they?

Cookies that are strictly necessary do not depend on the prior consent of the user and are essential to the functioning of the website or the provision of services (e.g. use of shopping trolleys, reserved log-in areas, security measures for bank payments). Performance and statistics cookies allow for the collecting of information about the way the Parques de Sintra website is used, such as browsing habits and number of users visiting the site, the length of each visit and which pages are visited. This allows Parques de Sintra to improve the site and adapt it to best suit the way in which it is used. Functionality cookies allow for the recognition of a user when they return to the Parques de Sintra website, which allows for the personalisation of some content (e.g. remembering previous language selection). Marketing cookies allow for personalised marketing to be directed at the user according to their interests.
